Decision-making by consumers, firms, and governments, and the effect of these decisions on the allocation of market failure and possible government responses.

#### 806 Policy Evaluation

Fall. 3(3-0) P:M: PPL 805 R: Approval of department.

Theoretical foundations for evaluation research and the practical aspects of conducting evaluations.

# 807 Public Policy

Fall. 3(3-0) P:M: PPL 801 or concurrently R: Approval of department.

Introduction to public policy and the policy-making process.

#### 808 Policy Development and Administration

Spring. 3(3-0) P:M: PPL 807 RB: PPL 801 and PPL 802 and PPL 803 and PPL 805 R: Approval of department.

Substance and dynamics of public policy-making in the United States. Conceptual foundations of and the practical constraints on governmental activity. Theories, models, and explanations of the policy process.

# 809 Cost-Benefit Analysis in Public Policy

Spring. 3(3-0) P:M: PPL 803 and PPL 805 R: Approval of department.

The conceptual foundations of cost-benefit analysis for setting policies to maximize economic efficiency.

# 810 Incentives and Public Policy

Spring. 3(3-0) P:M: PPL 805 R: Approval of department.

The evaluation of performance in modern organizations, particularly large bureaucracies, by means of "principal-agent" theory and "incentive-compatibility" analysis.

#### 813 Public Finance

Fall. 3(3-0) P:M: PPL 805 R: Approval of department

Economics of the public sector: how governments tax and spend revenues and the effects of these decisions on the economy.

## 890 Policy Workshop

Spring. 3(3-0) P:M: PPL 806 or PPL 810 or PPL 813 RB: 3 semesters in PPL program R: Approval of department.

Application of substantive and analytic skills to a concrete issue. Students act as a consulting firm to review some specific public policy and produce a summary report capable of informing future policy design.

#### 891 Issues in Public Policy

Practices and methods in diverse policy settings examined under the tutelage of policy professionals.

#### 894 Field Experience Practicum

Fall, Spring, Summer. 3(3-0) RB: 2 semesters in PPL program R: Approval of department.

Experience in administrative settings in the student's field of application. Opportunities to evaluate theories of public policy and administration by engaging in participant observation of the management of public policy.
